#### It is further clarified that:

\*No listed candidate with less than 50% (45% for the reserved category) marks in HS or its equivalent Exam should be admitted

\*No student of other media of instructions than the language medium of the Institute as per the medium-wise list with the notification of Admission of the relevant session, will be evaluated.

\*Any violation of the norms and standard, set and spelt out in the Regulatory Provisions & guidelines, issued from time to time shall lead to cancellation of the admission.

\*Candidates, selected under Vocational Category cannot be transferred to 'Non-vocational Category' and vice-versa.

\*Candidates under Management Quota, not over 10% of the sanctioned in-take in respect of only the Self-financed Private Unaided D El Ed Institutes, should be listed out separately and forwarded to the Board online for approval.

\*The Process of admission as per the given approved lists should be completed within seven days from the date of receipt of the provisionally approved merit lists.

\*And thereafter, a report of admission through our online system should be submitted to the Board for the next course of action..

\*In case the second, third or subsequent merit lists are approved by the Board, the admission in terms of those approved merit lists should be completed within seven days in respective cases from the date of receipt of such approved merit lists.

\*Separate approval for conversion of vacant deputation-seats, reserved for primary school teachers, appointed before 03.09.2001, as per the given guidelines, is required.

\*In case of an Ex-Service-man-category applicant, his army-graduation-certificate should be treated at par with 45%/50%, as the case may be, in HS/ or its Equivalent examinations, for admission to the Course.

\*All testimonials, mark-sheets, certificates, caste-category & PH Category Certificates etc. are to be verified with the originals.

\*In case of any deficiency/short-coming, found out on verification at the time of admission, the Head of the D El Ed Institute shall cancel the admission



- 1. 1. Having a rank in the Merit lists does not guarantee admission. Admission is strictly subject to the verification and authentication of the stated percentage of marks, date of birth, category, medium, academic qualifications, validity of Boards / Councils / Universities etc. with the original certificates, documents and testimonials.
- 2. For date of birth M.P. or its equivalent examination Admit Card/Certificate shall have to be verified in addition to verification of other documents uploaded by the applicant. The date of birth shall be recorded as in the M.P. or its equivalent examination Admit Card/Certificate. In case of difference the head of the institute may treat the application invalid.
- 3. If an applicant fails at any stage of such verification of details, her candidature will be cancelled by the authority of the Institution without referring the matter to the WBBPE for decision. The Institution authority will only forward a report of such cancellation to the Board.
- 4. Right to being enlisted in the SC/ST/OBC-A/OBC-B/PH category is reserved for candidates belonging to such category/ies, in terms of the valid certificates, issued by the competent authorities. .
- 5. All applicants for 4% (four percent) seats under Vocational Category shall, however, be considered as "Un-Reserved".
- 6. No vocational category candidate is eligible for the non-vocational-category-seats.
- 7. An enlisted candidate may be denied admission, if there is mismatch between the statements, made and the documents, produced at the time of admission.
- 8. Only prescribed fees are chargeable.
- 9. Classes shall start in pursuance of the Circular/Notice/Directives/Guidelines of the Government of West Bengal.
- 10. Subsequent Lists may be released only, if seats remain vacant category-wise after the expiry of the last date of reporting for admissionin terms of the First List.
- 11. For subsequently listed candidates four working days from the date of receipt of the list/s should be given
- 12. Candidates suffering from contagious diseases like viral influenza, CORONA-viral infection etc. should not be asked to appear physically for admission. For their physical appearance, a certificate of a registered medical practitioner, preferably attached to Government-run-Health Centres / Hospitals will be required.
- 13. All the relevant testimonials should be forwarded to the relevant Board /Council for verification immediately after admission
- 14. The List of candidates admitted should be sent online (as per instruction to be issued) to the West Bengal Board of Primary Education immediately after admission process is over.
- 15. The provisionally approved merit lists of Management Quota candidates/In-service-Category applicants shall be sent afterwards on having the same from you for approval.

The above guidelines must be walled up in the Institution in full view of all concerned for knowledge and information of all.
