NOTICE

RE-VALIDATION OF THE LIST OF STUDENTS ADMITTED IN THE TWO-YEAR D. EL. ED. COURSE, SESSION 2023-2025 FOR OBTAINING THEIR REGISTRATION CERTIFICATES.

Whereas, the West Bengal Board of Primary Education has published a Notification vide No. 400/WBBPE/D.EL.ED./2024/80P-06/2024 dated 19/06/2024 for issuing digitised Registration Certificates for the students admitted in the Two-Year D. El. Ed. Course, session- 2023-2025 in the institutions recognised by the NCTE and affiliated to WBBPE.


And whereas, the Board has received several prayers from the heads of the D. El. Ed. Institutions that it is not feasible for the institutions to collect Registration Fees from the students who are unable to continue the course or who are absent in the institute for a long period of time in the session 2023-2025.

And whereas, the Director, SCERT, WB has requested the Board in the letter No. 560/F. No. 563/SCERT/2024 dated 27/06/2024 to reconsider the decision taken by the Board of collecting Registration Fees from all the admitted students of DIETs and PTTIs (Govt./ Govt. Sponsored/Govt. Aided) in West Bengal and allow the institutes to collect Registration Fees only from the regular students who are eligible for pursuing D. El. Ed. Course, session 2023-2025 as per extant norms and procedures.

Now, the West Bengal Board of Primary Education (WBBPE) has decided to open the admission portal on **29/06/2024 and 30/06/2024** for rectification/modification the admission list of the students of the session 2023-2025.

For such rectification/modification, the heads of the institutions are requested to upload an undertaking in their log-in with the name of the students and proper application ID generated at the time of submission of their applications through online portal of the WBBPE.

In this perspective the WBBPE has also decided to extend the last date for deposition of requisite fee of Rs. 1000/- (Rupees one thousand) only per applying students for downloading digitised Registration Certificates up to **10th July, 2024.**
