### **NOTIFICATION FOR ADMISSION FOR THE SESSION:2025-27.**

I am directed by the secretary of WBBPE to inform the following candidates that, they have been provisionally selected for admission for the session 2025-2027, but this selection is subject to final verification at the time of admission. The provisionally selected candidates are hereby directed to submit the original testimonials along with Xerox copies with self attestation and Rs.7700/- (seven thousand and seven hundred as per existing fees structure (If revised fees structure supplied during the admission process then every admitted students shall have to repay) only for the admission fees prescribed by the West Bengal Board of Primary Education and Rs.2000/- (Rupees Two Thousand) for hostel charge in advance.

- 1. Last date of admission is 10/10/2025 by 04.00 P.M.
- 2. Rules and norms have been stated in the Admission Notification/Publication of Short Merit list vide Memo No.1295/WBBPE/D.El.Ed./2025/95P-06/2025, date-18/09/2025 by the WBBPE, should be followed strictly at time of admission.
- 3. Original mark sheet, certificate, M.P admit/certificate, ID proof (Aadhaar card, Voter ID or any valid document), caste certificate, P.H. certificate, ex-serviceman's certificate/ppo (whichever may be applicable for which category) should be produced at the time of admission.
- 4. One set of Xerox copies of H.S mark sheet, M.P certificate/admit card, caste certificate if any.
- 5. Two copies recent passport size photograph (Colour).
- 6. Separate bond for anti ragging must be submitted at the time of admission by the trainee.
- 7. Rules for uniform will be supplied at the time of admission.
- 8. Candidates are also requested to follow COVID-protocols like 'physical distancing', 'wearing masks', using hand-sanitizers while visiting institute for admission.

### Points to be noted:-

- 1. 80% for theory papers & 90% for practicum papers attendance must have secured.
- 2. Residing in the hostel is compulsory for the trainees.
- 3. His name may be struck off from the roll even after admission for any of the following:
  - a. If he is medically unfit, Candidates suffering from congenital and contagious diseases.
  - b. Expecting mother.
  - c. His conduct and behavior is unsatisfactory. If he/she does not obey the rules and regulations of the hostel and institute.
  - d. For fifteen (15) days absence from date of admission.
  - e. If any certificate/mark sheet submitted by the candidate is proved false. This is for information of all concerned.

#### Sir/Madam,

With reference to the above, I would like to enclose herewith provisionally approved merit list/s of students for admission into two year D.EL.ED. course (Regular) for the Session-2025-2027 for your Institute. The category-wise merit lists containing 28 candidates who have been provisionally selected for admission (copy enclosed)and the remaining 5 candidates are selected provisionally as wait-listed candidates in order of merit.

A separate Merit List of the 0 Candidate/s, selected under Vocational Category, is also enclosed for taking necessary action.

Guidelines regarding use of Approved Merit Lists for Admission to Two Year D. EL ED. Course (Regular)—2025-2027 should strictly be followed.

The uploaded/given declarations/data with the original certificates / testimonials /documents for authentication of candidature, at the time of admission have to be verified first.

Then authenticity of the following information before issuing the order for admission have to be verified:

- 1. i.Percentage of Marks in H.S or its equivalent Examination as per NCTE-norms, read with Admission Notification/s
  - ii.Language studied other than English
  - iii.Perfect match of the medium of the Institution as per the list of the D.EI.Ed Institutions, annexed to the Admission Notification of 2025-2027 with the medium opted by the applicant
    - iv.Upper age limit
    - v.Caste & Category Certificates (When applicable)
      - vi.Proof of belongingness to Ex- Servicemen Category
      - vii. Domicile Certificate (For Admission to Santali Medium Institute/Unit only)

If any candidate is detected with inadequate information in respect to any of the above-noted candidate-specific stipulations, then he/she should not be admitted. If admitted otherwise, then the entire responsibility of such 'inadmissible admission' and consequent cancellation of admission by the Board on further verification, shall lie on the institute itself and the Board will be not liable for any legal complications..

#### It is further clarified that:

- 2. No listed candidate with less than 50% (45% for the reserved category) marks in HS or its equivalent examination should be admitted.
- 3. No student of other media of instructions than the language medium of the Institute as per the medium- wise list in the notification of Admission of the relevant session, will be admitted.
- 4. Any violation of the norms and standard, set and spelt out in the Regulatory Provisions & Guidelines issued from time to time, shall lead to cancellation of the admission.
- 5. All applicants for 4% (four percent) seats under Vocational Category shall, however, be considered as "Un Reserved". Candidates, selected under Vocational Category cannot be transferred to 'non-vocational category' and vice-versa.
- 6. The Process of admission as per the provided approved lists should be completed within five working days from the date of publication/notification of the provisionally approved merit lists by the concerned institute.

Subsequent Lists may be released only, if seats remain vacant category-wise after the expiry of the last date of reporting for admission in terms of the First List.

Thereafter, a report of admission through our online system should be submitted to the Board for the next course of action.

After the expiry of the validity of the Approved First Merit List/s, i.e. five working days from the date of publication of such merit lists, the Board will approve and forward the remaining merit listed candidates for the concerned Institute/s with an order to generate category wise lists for admission on the basis of the master waiting list/s (all inclusive) as per the requirement of the concerned Institute in terms of the approved intake capacity

A similar master merit list (all inclusive) will be approved and forwarded for use for admission of vocational category candidates as per the requirement of the concerned Institute in terms of the approved intake capacity

For such second, third or subsequent merit list/s, to be generated by the authority of the concerned Institution in order of merit as per rules / guidelines/ order/ notifications of the Board, on the basis of the

approved master waiting list/s, (One Time Despatch), the admission should be completed in not more than three working days from the date of generation/walling up of such merit list/s.

- 7. Separate approval for conversion of vacant deputation-seats, reserved for primary school teachers, appointed before 03.09.2001, as per the given guidelines, is required.
- 8. In case of an Ex-Service-man-category applicant, his army-graduation-certificate should be treated at par with 45%/50%, as the case may be, in HS or its Equivalent examinations, for admission to the Course.
- 9. All testimonials, mark-sheets, certificates, caste-category & PH Category Certificates etc. are to be verified with the originals.
- 10. In case of any deficiency/short-coming, found out on verification at the time of admission, the Heads of the D.El.Ed Institutions shall cancel the admission after a second thorough checking.
- 11. Having a rank in the Merit lists does not guarantee the admission of a candidate. Admission is strictly subject to passing the verification and authentication of the stated percentage of marks, date of birth, category, medium, academic qualifications, validity of Boards / Councils / Universities etc. with the original certificates, documents and testimonials.
- 12. For varification of the date of birth of a candidate, M.P. or its equivalent examination Admit Card/Certificate shall have to be verified in addition to verification of other documents uploaded by the applicant. The date of birth shall be recorded as in the M.P. or its equivalent examination Admit Card/Certificate. In case of difference the head of the institute may treat the application as invalid and is liable to be rejected.
- 13. If an applicant fails at any stage of such verification of details, his/her candidature will be cancelled by the authority of the Institution without referring the matter to the WBBPE or any other authority, for decision. The authority of the concerned Institute will only forward a report of such cancellation to the Board.
- 14. Right to being enlisted in the SC/ST/OBC/EWS/PwD/EX-SERVICEMEN/IN-SERVICEMEN category is reserved for candidates belonging to such category/ies, in terms of the valid certificates, issued by the competent authorities.
- 15. An enlisted candidate may be denied for admission, if there is any mismatch between the statements, made and the documents, produced at the time of admission.
- 16. Only prescribed fees are chargeable.
- 17. Classes shall start on and from 24th September, 2025 (if not stated otherwise) in pursuance of the Circular/ Notice/ Directives/ Guidelines of the Government of West Bengal after admission of students.
- 18. All the relevant testimonials should be forwarded to the relevant Board /Council for verification immediately after admission of candidates.
- 19. The List of candidates admitted should be sent online (as per instruction to be issued) to the West Bengal Board of Primary Education immediately after admission process is over.
- 20. The vacancy/seats reserved for EWS, PwD, Ex-Servicemen, In-Service category shall be filled up by the candidates from "Un-Reserved" category according to merit, if no suitable candidate is available in the said categories subject to the approval of the WBBPE.
